**Standards and Expectations of Behavior  
for Participants and Leaders at Overnight and/or Off-site Youth Events.**

- All youth must have signed consent forms on file to attend any over night or off-site events.
- All youth are required to wear their seatbelt at all times when riding in the church van or an accompanying vehicle.
- All overnight activities will provide separate sleeping arrangements for males and females.
- No use of alcohol, any tobacco products, or illegal and illicit drugs. Any Youth in violation of this standard will be sent home immediately. *(Use of alcohol and tobacco is illegal for young people. In order to model safe and healthy behaviors, adults present at youth events will neither use, possess, nor be under the influence of alcohol, tobacco, or illegal/illicit drugs.)*
- There are to be no weapons, firearms or fireworks at youth events.
- Sexual relations or excessive displays of affection are strictly prohibited.
- There is to be no explicit language at any time.
- No one will be allowed to leave the premises at any time without an adult.
- All youth will follow the "Lights Out" time given by any adult leader.
- Treat everyone and everything with respect at all times.
- During youth group discussion groups the use of cell phones is not allowed. This rule will also be enforced at other youth events as necessary. The cell phone numbers of adult leaders will be shared with parents.
- Leave all areas clean.

**Expectations**

Every parent or guardian should also understand that the Adult Representatives of 1st Presbyterian Church are responsible for maintaining order and administering discipline during the duration of an event in which your youth is participating. Should a youth, in the view of the Adult Representatives, become a chronic disciplinary problem or is not following the standards of behavior the parent or guardian will be contacted to pick the youth up immediately.
